I, the Participant, request to participate in the **Junee Ultimate Ninja** (the “Event”) run by Junee Shire Council (“Council”) and its associated entities which includes the Junee Junction Recreation & Aquatic Centre. In consideration of being allowed to participate in the Event, I hereby acknowledge and agree as follows:

1. The activities that I may participate in as part of the **Junee Ultimate Ninja** are potentially hazardous and may involve a risk of injury. I am fully informed or otherwise aware of the potential risks involved in my participation in the Event. I declare that I am in sufficient physical and mental health to participate in the Event and do not have any physical or mental conditions which could affect my ability to participate, or should preclude me from involvement in the Event.
2. My participation in the Event is entirely at my own risk. Junee Shire Council will not be liable for any personal injury or death that I may suffer as a result of my participation in the Event. I will not make any claim against Junee Shire Council and/or its directors, employees, agents or related entities in relation to any personal injury or death that I may suffer as a result of my participation in the Event.
3. I acknowledge that I am responsible for my own insurance and ambulance cover and give my consent to receiving any medical treatment deemed necessary by Junee Shire Council or any medical professional.
4. I agree to comply with all instructions and directions made by Council or its employees and agents while participating in the Event. If my participation or conduct in the Event is at any time deemed detrimental to the Event or dangerous to its other participants, as determined by Council in its sole discretion, I understand that (a) I may be expelled from the Event without Council incurring any liability; and (b) I may incur liability to Council as a result of any loss or damage it suffers as a result.
5. I fully and forever **RELEASE, WAIVE AND DISCHARGE, COVENANT NOT TO SUE and INDEMNIFY** Junee Shire Council (including, but not limited to, its trustees, directors, employees, agents, representatives and associated entities which includes the Junee Junction Recreation & Aquatic Centre), from and for any and all demands, claims, actions, suits, damages, losses, liabilities, costs and expenses (including, but not limited to, court costs and legal fees), from any cause whatsoever (including, but not limited to, delays and cancellations, property damage and loss, bodily injuries, sickness, disease and death), directly or indirectly, whether brought by me or by third parties, arising in connection with my participation in the Event, or as a result of my own conduct whilst participating in the Event, whether or not foreseeable or contributed to by any act or omission of Council or others.
6. By signing this document, I will waive certain legal rights, including the right to sue or claim compensation.
7. This Waiver and Release may not be amended, by course of conduct or otherwise, unless agreed to by Council in writing.

I, the Participant, have read and fully understand this Waiver and Release. I intend that this Waiver and Release be legally binding upon and enforceable against me and my family, estate, heirs and legal representatives. I confirm that I am at least eighteen years old, fully competent, and entering into this Release and Waiver voluntarily of my own judgment.

RULES and INSTRUCTIONS

To participate in the **Junee Ultimate Ninja** event, you must read and abide by the following Rules and Instructions:

- The Event will be managed and coordinated by Junee Junction Recreation and Aquatic Centre (JJRAC). If you have any questions about the event prior to the day, please contact the Centre on 02 6924 4680.
- The Event will be held at the JJRAC, utilising the Stadium, the outdoor grassed areas and the Main Pool.
- The Event will commence at 10.00am on Saturday 21st October. Participants must be in attendance at the Stadium by 9.45am for the Event Briefing.
- It is anticipated that the entire event will be completed by 2.00pm.
- All participants must be 9 years of age or over.
- Participants aged 9 to 17 must get a parent/guardian to sign the **“Registration Waiver and Release Form”**
- Each team must consist of 4 participants. Each participant must individually complete the **“Registration Waiver and Release Form”**
- Each team must have a nominated captain who is the sole authorised representative to approach the event coordinators with any issues or complaints.
- All participants **MUST** wear appropriate clothing and footwear to safely participate in the Event.
- **NOTE:** the first activity in the Event is the inflatable obstacle course, all participants must go through this activity wearing socks as shoes are not permitted.
- Please note that there is an activity in the Main Pool so participants are advised that appropriate swimming attire (and a towel) may be required.
- **NOTE:** the Main Pool component of the event will be the last activity, participants will not be required to change out of their swimming attire to complete any other activity.
- Participants are strongly advised to have their own water readily available to stay hydrated throughout the event. Water is also available at the Centre.
- Participants are advised to obtain a copy of the **“Junee Ultimate Ninja** obstacle course “mudmap” and instructions” which will be available at the JJRAC front reception 2 weeks prior to the Event. This document will provide participants with information about each individual activity in the Event and how to successfully complete it to move on to the next activity.
- Participants must, at all times, follow the instructions of the event coordinators.
- Any decision made by the event coordinator will be final.
